Minutes of the Regular Meeting of the Board of Trustees

May 18, 2016

The Board of Trustees of the Texas Southmost College District convened in open session on May 18, 2016, at 5:30 p.m., in the Gorgas Board Room at Texas Southmost College. Board members present were Francisco G. Rendon, Chair; Trey Mendez, Vice Chair; Dr. Reynaldo García; Adela G. Garza; Ramon Champion Hinojosa; and Art Rendon. Absent was Ed Rivera, Secretary. Also present was Dr. Lily F. Tercero, President of Texas Southmost College.

1. Call to Order

The meeting was called to order by Chairman Rendon at 5:30 p.m.

2. Speakers to Agenda Items and Public Discussion

There were no speakers.

3. Mission Statement

Chairman Rendon read the mission and role and scope for Texas Southmost College District as follows:

Transforming our communities through innovative learning opportunities.

Texas Southmost College's mission is guided by our commitment to provide:

4. President's Report

Chairman Rendon called on Dr. Tercero to give the report. Dr. Tercero announced new employees: Cristina Madrid, Coordinator of Risk Management, Business Services; Aida Garza, Financial Aid Specialist, Financial Aid; and Yokebed Valdez, Child Development Specialist, Child Care Center. She announced employees with new positions: Juana Graciela Hernandez, Senior Accounting Clerk, Business Services and Nilda Mora, Administrative Assistant, Purchasing and Records Retention.

Dr. Tercero announced that she has been asked to serve as a faculty member of the National Community College Hispanic Council's Leaders Fellows Program. She stated that the National Community College of Hispanics Council is an affiliate council of the American Association of Community Colleges a national association for community colleges since 1985 and have been preparing and supporting Hispanics for leadership positions in community colleges across the United States. She said she was honored and humbled.

Chairman Rendon called on Dr. Tercero to present the item. She stated that this is a new policy for the board as part of the governance, BBF Ethics. She said that it is a policy that Texas Association of School Boards (TASB) recommends as a local policy for governing boards.

A motion was made by Mr. Hinojosa to table the item on Adopting the Local Policy, as presented. The motion was seconded by Mrs. Garza. Mr. Hinojosa, Mrs. Garza and Dr. García voted aye. Mr. A. Rendon, Mr. Mendez, and Mr. F. Rendon voted nay. Motion did not pass.

A motion was made by Mr. A. Rendon to Approve the Local Policy, BBF Ethics, as presented. The motion was seconded by Mr. Mendez. Mr. A. Rendon, Mr. Mendez, Mr. F. Rendon, and Dr. García voted aye. Mr. Hinojosa and Mrs. Garza voted nay. *Exhibit "B"*

Mrs. Garza stated that this policy will need to be brought back to the board for final approval given that two board members voted against the motion.

Chairman Rendon agreed that if you don't have a 2/3 vote it will need to be brought back to the Board for approval.

The Board did not convene in Executive Session; Mr. Frank Perez, TSC Board Attorney, announced there were no items to discuss.

Chairman Rendon called on Mr. Chrnko-Salas to present the item. Mr. Chrnko-Salas presented the election results for the TSC District Trustee election held on May 7, 2016, for Places 3, 4 and 5. Mr. Chrnko-Salas announced that Trey Mendez was duly elected to Place 4 with 4,289 votes and Ruben Herrera was duly elected to Place 5 with 4,711 votes. All candidates must receive majority of votes cast.

A motion was made by Mrs. Garza to Approve the Canvassing of Results of the Texas Southmost College District Election, as presented. The motion was seconded by Mr. Hinojosa and carried unanimously. *Exhibit "C"*

A motion was made by Dr. García to Approve the Order Declaring Results of the Texas Southmost College District Election, as presented. The motion was seconded by Mr. Mendez and carried unanimously.

The motion was amended by Mr. Mendez to change the date to June 18th on the Approval the Order Declaring Results of the Texas Southmost College District Election. The motion was seconded by Mrs. Garza and carried unanimously. *Exhibit "D"*

12. Consideration and Approval of the Notice and Order of the Runoff Election

Consideration and Approval of the Notice and Order of the Runoff Election

Chairman Rendon called on Mr. Chrnko Salas to present the item. Mr. Chrnko Salas stated that as per the Election Code, political subdivisions are required to publish a notice and order of election on or before the 21st day before the election. For the June 18, 2016 election, this date would be on or before Monday, May 23, 2016. The notice and order includes the type and date of election; the location of each polling place; hours the polls are open; location of each early voting place; dates and hours for early voting; and the early voting clerk's mailing address. As per the Election Contract with the Cameron County Elections Administrator, the notice and order proposes 20 polling locations for General Election Day and 6 early voting sites.

The notice and order will be published in the Brownville Herald, Los Fresnos News, Port Isabel – South Padre Island Press, and the San Benito News on or before Monday, May 23, 2016. The notice will be published in English and Spanish as required by law.

A motion was made by Mrs. Garza to Approve the Notice and Order of the Runoff Election, as presented. The motion was seconded by Mr. Hinojosa. The agenda item was discussed by the board.

The motion was amended by Mrs. Garza to Approve the Notice and Order of the Runoff Election for Election Date of June 18th. The motion was seconded by Dr. García and carried unanimously. *Exhibit "E"*

Staff recommends holding a drawing on May 19th at 11:00 a.m. at the Gorgas Board Room.

A motion was made by Mrs. Garza to Approve the Setting Date and Time for Drawing Place on Ballot, on May 19th, 11:00 a.m., at the Gorgas Board Room, as presented. The motion was seconded by Mr. Hinojosa and carried unanimously. *Exhibit "F"*
